Terms and Conditions

Thank you for your interest in AWS Girls' Tech Day (the "Event"). The Event is a one-day event designed to inspire and empower young girls from grades 3 to 12, and young women 18 to 24 years of age, to pursue interests and careers in technology. It is a series of learning workshops focused on science, technology, engineering, and mathematics (STEAM), and the arts.

By clicking "I agree to the Terms and Conditions" at the end of this page, you acknowledge and agree to the Terms and Conditions for the Event as provided below. Please read carefully and click the box to notate your acknowledgement, agreement and consent.

Girls' Tech Day Parent Authorization

For any minor children under the age of 18 (hereinafter referred to as "Minor", "Child" or "Children"), the parent or legal guardian of such Minor must give their approval for his/her participation in the Event. By clicking "I agree to the Terms and Conditions" at the end of the page, you acknowledge and agree to the terms herein and consent to your child's participate in the Event.

Girls' Tech Day/Photo Release

You acknowledge and agree that this event may be photographed and filmed. You authorize the use of your image/your child's image in film, video or photography for internal and external promotional or marketing purposes for Amazon Web Services and its affiliates.

Event Participation Authorization and Release

This Event Participation Authorization and Release (this "Release") between Amazon Web Services, Inc., a Delaware corporation ("AWS"), and you (individually, on behalf of the company you represent, or both) ("you") is made and entered into as of the date you agree to these Terms and Conditions.

License to Use Items:

In consideration for the opportunity to participate in the Event, you grant to AWS and its affiliates, agents, employees and assigns an irrevocable, nonexclusive, royalty-free right and license throughout the world and in perpetuity to reproduce, edit, publish, distribute or translate, for advertising, publicity and promotional purposes or for any other purpose relating to AWS's business, all or any part of the following items ("Items"): (a) all still photographs and all audio and video recordings that AWS or its independent contractors make of you or your voice, image or likeness in connection with the Event, including the right to use your name, image, likeness and biographical information, and (b) all materials (electronic or hard copy) submitted or presented by you in connection with the Event. You consent to the use of the Items pursuant to the foregoing in perpetuity without compensation (unless prohibited by law) or additional consents from you.

Representations and Covenants:

You represent and warrant that the Items do not violate or infringe any copyright, trademark or other proprietary right of any person or entity. You represent and warrant that you and your financial institution(s) used to fund any fees associated with your participation in the Event are not subject to sanctions or otherwise designated on any list of prohibited or restricted parties or owned or controlled by such a party, including but not limited to the lists maintained by the United Nations Security Council, the US Government (e.g., the US Department of Treasury's Specially Designated Nationals list and Foreign Sanctions Evaders list and the US Department of Commerce's Entity List), the European Union or its member states, or other applicable government authority.

Release of Claims:

You hereby release AWS and its affiliates, successors and assigns, and their respective officers, directors, employees, and agents, from any and all claims that you may have now or in the future associated with the Event or the Items, including without limitation claims arising from rights of publicity, privacy, or any intellectual property rights.

No Compensation for Use of Items:

You acknowledge and agree that AWS will not compensate you or your successors, licensees or assigns for any use of the Items or any accompanying identifying characteristics. You acknowledge and agree that the Items may be edited in AWS's sole discretion and you waive any right to inspect and/or approve any use of the Items. You also understand that AWS is not obligated to promote or use the Items in any form. You agree that you, through participation in the Event and through this Release, have acquired no rights in any AWS intellectual property, including but not limited to the right to use any AWS trademark, copyrighted material or other intellectual property, in any manner or in any format.

No Injunctive Relief:

You acknowledge and agree that you will not be entitled to any injunctive or other equitable relief in connection with the Items or your participation in the Event.

Choice of Law:

These Terms and Conditions will be governed by and construed in accordance with the laws of the State of Washington, USA, without regard to the conflict of laws provisions thereof or other principles which might result in the application of any law other than the State of Washington.

Entire Agreement:

This is the entire agreement between you and AWS with respect to the subject matter hereof and supersedes any previous or contemporaneous oral or written agreements regarding such subject matter.

THESE TERMS AND CONDITIONS PROVIDE AWS WITH YOUR ABSOLUTE AND UNCONDITIONAL CONSENT, WAIVER, AND RELEASE OF LIABILITY, ALLOWING AWS TO USE YOUR NAME, LIKENESS, AND OTHER PERSONAL CHARACTERISTICS AND PRIVATE INFORMATION FOR THE LIMITED PURPOSES SET OUT ABOVE. BY SIGNING, YOU ACKNOWLEDGE AND AGREE THAT YOU HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THESE TERMS AND CONDITIONS AND THAT YOU ARE WAIVING ALL RIGHTS TO PURSUE AWS WITH RESPECT TO OR IN CONNECTION WITH THE EVENT.

Privacy Policy

AWS is committed to protecting your privacy: it's the foundation for a safe and trusted community. Our privacy policy outlines what information we collect from you, how we use that information, and what choices you have regarding how and whether we can use your information. AWS will handle children's personal information as described in this privacy policy below. Since the Event is a learning and educational environment for children, we take additional measures to safeguard children's privacy, including for children under the age of 13. Please see our privacy policy below, which further outlines our approach.

This section explains our information collection, disclosure, parental consent practices and parental choice procedures (with respect to information provided by children under the age of 13 ("Child" or "Children")) and other information processing whether in respect of a Child or other participants who are not Children ("Participant"). This policy is in accordance with the U.S. Children's Online Privacy Protection Act ("COPPA"), and outlines our practices in the United States regarding Children's personal information. For more information about COPPA and general tips about protecting Children's online privacy, please visit <https://www.consumer.ftc.gov/articles/0031-protecting-your-childs-privacy-online>. Where applicable. In addition to COPPA, this privacy policy also addresses the information we need to provide to you under the General Data Protection Regulation ("GDPR") and other similar international privacy laws. For the purposes of GDPR, Amazon Web Services, Inc. will be the "controller" of personal information collected in respect of any Child or Participant at the Event.

Information may be collected directly from Participants for registration purposes. AWS will collect information about Children directly from their parents, who will provide us with limited information for their Child solely for registration purposes. In addition, Children and other Participants may share information about themselves during the Event. The Event will take place over online videos in which video images and audio of the Children and other Participants may be recorded. No information is collected directly from Children until they are in the Event session. Children and other Participants may also share information about themselves during the Event session voluntarily. While AWS expects

all Participants and users to abide by our standards of conduct, please note that we cannot control or monitor what personal information you/your Child shares with third parties, nor what those third parties ultimately do with that information, and we disclaim all responsibility in that regard.

Class Video Recordings: As described above, AWS may record video of Children and participants during Event sessions (“Event Recordings”). AWS may also use Event Recordings to provide feedback to for future events and programming and for compliance purposes. While we expect third parties to abide by our standards of conduct, please note that we cannot control or monitor what such third parties ultimately do with Event Recordings, and disclaim all responsibility in that regard.

Parental Consent and Lawful Basis: AWS obtains verifiable parental consent before collecting personal data from your Child, or from you, where we are relying upon your consent. If you do not consent, then we will not collect, use or disclose any personal information about your Child or you, and you/your Child may not be allowed to use the services in any way. If you are not using our services for any other purposes and do not provide parental consent within a reasonable time from the date the direct notice was sent, we will also delete your online contact information from our records.

For Participants in the European Union, who are not Children, AWS will use the personal information we collect as part of your attendance at the Event on the basis of our legitimate interests to properly administer and operate the Event. On balance, AWS consider that we have a legitimate interest in processing your personal information in order to allow you to take part in the Event and effect its proper administration.

When we are required to share personal information in relation to a Participant in the circumstances set out in the section below, we will rely on our legal obligation to share this information with those third parties.

For Participants outside of the EU, who are not Children where we cannot rely on our legitimate interest or other legal basis, we rely on your consent.

What Child’s or other Participant’s Information is Shared with Others? We don't uncover to outsiders any Child's or other Participant’s personal information that we gather other than as follows, in compliance with applicable law: (a) with a parent's authorization, (b) as required by any relevant law, (c) to third-party services who help us work or deal with the site or programming of the Event, (d) to conform to legal process, (e) to respond to legislative solicitations, (f) to ensure our operations, (g) for assistance in fraud detection and prevention; (h) to secure the rights, protection, well-being or property of AWS, your child or others, (i) to allow us to pursue available remedies or limit the damages that we may sustain, and (j) in connection with a disposition of all or a considerable part of our business, resources or stock, for example, a deal, merger, consolidation, redesign, joint venture, task, or bankruptcy or comparable procedures.

Parents Control over Child’s Information. Parents / Guardians may at any time access or change the individual data that we have gathered online from their Children. Parents may likewise solicit us to stop accumulation of information from their Children, or to make no further utilization of, or erase, the individual data we have gathered online from their Children, in which case, the Child's record will be erased.

Where in the World is Your / Your Child’s Information Transferred To: Some of the people we share your information with may process it overseas. This means that your / your Child’s personal information may on occasion be transferred overseas. Some countries already provide adequate legal protection for your / your Child’s personal information, but in other countries, additional steps will need to be taken to protect it.

You can contact us for more information about the safeguards we use to ensure that your / your Child’s personal information is adequately protected in these circumstances (including how to obtain copies of this information).

How Long Will We Keep Your / Your Child’s Information: We will not retain your / your Child’s personal information for longer than is necessary. We keep personal information for long enough to ensure that, we can administer the Event and answer any queries, or where we have a legal obligation to retain it.

What are Your Right's / Your Child's Rights: You / your Child have rights in relation to the personal information we collect at the Event. You / your Child have the right to:

- make a request to have personal information corrected if it is inaccurate, and completed if it is incomplete;
- in particular circumstances, restrict the processing of personal information;
- in particular circumstances, ask to have personal information erased;
- request access to your / your Child's personal information and to obtain information about how we process it;
- in particular circumstances, move, copy or transfer personal information;
- in particular circumstances, object to us processing the personal information;
- not be subject to automated decision-making including profiling where it produces legal or other significant effects on you / your Child.

All of these rights can be exercised free of charge except in some very limited circumstances, and we will explain these to you where they are relevant.
